Management Discussion of Fund Performance

INVESTMENT OBJECTIVE AND STRATEGIES

The Fund will invest in a combination of large capitalization Canadian companies and smaller and medium Canadian companies. The Fund's objective is to provide long-term growth of capital.

The Fund will invest 60% of the portfolio using a passive strategy of investing in the common shares of the 50 largest capitalized companies listed on the Toronto Stock Exchange, excluding holding companies. We have retained Shaunessy & Company Ltd. of Calgary, Alberta as the portfolio sub-advisor for this 60% of the Fund's portfolio.

The Fund will actively manage the remaining 40% of the portfolio, investing primarily in shares of smaller and medium sized Canadian companies that are expected to profit from future economic growth. Galileo Equity Management Inc. is the portfolio advisor for this 40% of the Fund's portfolio. The portfolio manager uses a bottom-up, growth investment style. It seeks to invest in companies at an early stage of their development and hold them until they achieve success through rising sales, earnings and cash flow.

As part of its strategy, the Fund may engage in short selling as a result of special relief it obtained from the Canadian securities regulators and engage in securities lending as permitted by securities regulators.

RISK

The Fund was launched on November 14, 2006. Between the time of its launch and the end of 2006, the Fund invested the actively managed portfolio comprising 40% of the Fund. During the first six months of 2007, the Fund invested the passive portfolio in the 50 largest capitalized companies listed on the Toronto Stock Exchange. The Fund does not hold any foreign stocks.

Investors in the Fund should have a long-term investment horizon.

The Fund did not perform any short selling or securities lending in the first six months of 2007.

RESULTS OF OPERATIONS

The performance for the period January 1, 2007 to June 30, 2007 for the Class A and Class F units of the Fund was 11.99% and 12.35% respectively. The Fund performance beat the Fund's benchmark, the S&P/TSX Composite Index, which had a return of 7.73% for the same period.

Securities that performed particularly well, relative to the Index, in the last six months include NaiKun Wind Energy Group, Molly Mines Ltd, Benton Resources and Plutonic Power Corporation. Specific securities in the Fund that underperformed the Index in the last six months include Western Uranium Corporation, Jura Energy Corporation and Tango Energy Inc.

RECENT DEVELOPMENTS

This Fund was established on September 14th, 2006 and amended on November 1, 2006. On November 14th, 2006, the 13 provincial and territorial securities commissions of Canada gave final receipt of the Simplified Prospectus for the Galileo Funds, which allowed the units to be sold to retail investors.

The name of the Portfolio Manager of the Fund changed from Galileo Equity Management Inc. to Galileo Funds Inc.

RELATED PARTY TRANSACTIONS

Galileo Funds Inc., the Fund's Manager and Trustee, is a wholly owned subsidiary of Galileo Equity Management Inc., which is the Fund's Portfolio Advisor. Galileo Funds Inc. receives management fees based on the average net assets of the Fund. The management fees are used to pay for sales and commissions, the investment management of the Fund and other general administration. For the six month period ended June 30, 2007, the total management fees charged by Galileo Funds Inc. to the Fund was \$1,513.

- (3) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a Fund's portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a Fund.
- (4) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net assets during the period.

MANAGEMENT FEES

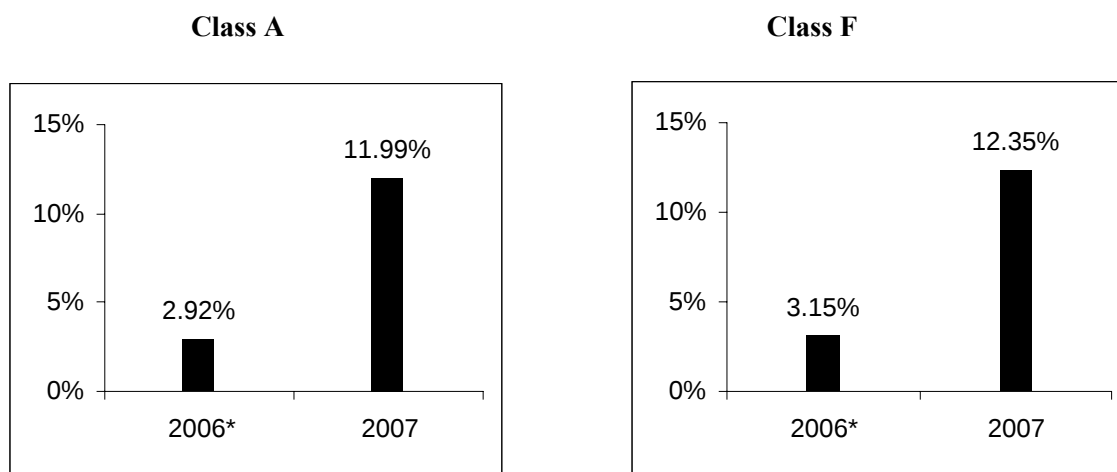
The Fund pays an annual fee of 1.85% of the net asset value of Class A and 0.85% of the net asset value of Class F plus GST to the Fund Manager in consideration for the provision of management, distribution and Fund advisory services. This management fee is calculated as a percentage of the Fund's net assets per class and is calculated and credited daily. The Fund is required to pay Goods and Services Tax (GST) on the management fee.

PAST PERFORMANCE

The performance information shown below assumes that all distributions made by the Fund in the period shown were reinvested in additional units of the Fund. The performance information does not take into account sales, redemptions, distributions or other optional charges that would have reduced returns or performance. It is important to note that the past performance of the Fund does not tell you how the Fund will perform in the future.
