Management Discussion of Fund Performance

INVESTMENT OBJECTIVE AND STRATEGIES

The Fund invests in a combination of large capitalization Canadian companies and smaller and medium Canadian companies. The Fund's objective is to provide long-term growth of capital.

The Fund invests 60% of the portfolio using a passive strategy of investing in the common shares of the 50 largest capitalized companies listed on the Toronto Stock Exchange, excluding holding companies. Shaunessy & Company Ltd. of Calgary, Alberta is the portfolio sub-advisor for this 60% of the Fund's portfolio.

The Fund actively manages the remaining 40% of the portfolio, investing primarily in shares of smaller and medium sized Canadian companies that are expected to profit from future economic growth. Galileo Global Equity Advisors Inc. is the portfolio advisor for this 40% of the Fund's portfolio. The portfolio manager uses a bottom-up, growth investment style. It seeks to invest in companies at an early stage of their development and hold them until they achieve success through rising sales, earnings and cash flow.

As part of its strategy, the Fund may engage in short selling as a result of special relief it obtained from the Canadian securities regulators and engage in securities lending as permitted by securities regulators.

RISK

The active portion of the Fund held a number of foreign listed securities in the first quarter of 2008. A significant number of which were listed on the Hong Kong stock market. As this market continued to experience declines the positions were eliminated and now the Fund has a very modest amount of foreign exposure. The Fund did not participate in any short selling or securities lending during 2008.

Investors in the Fund should have a long-term investment horizon.

RESULTS OF OPERATIONS

The Fund had net redemptions for the year and combined with the negative performance resulted in the net assets of the Fund decreasing by over 50% in 2008. Interest income declined from 2007 as interest rates in Canada were repeatedly cut by the Bank of Canada. The dividends increased in 2008, as the portfolio held more dividend yielding securities.

The Fund performance was (41.31%) and (40.69%) for the Class A and Class F units of the Fund respectively for the first half of 2008. The Fund underperformed its benchmark, the S&P/TSX Composite Index, which had a return of (35.03%) for the same period.

The passive portion of the Fund outperformed the benchmark as a result of the equal weighting of the holdings which limited the exposure to the strong underperforming financial securities in the index. The active portion underperformed the benchmark as a result of a flight to liquidity in the market. A number of the small and mid cap securities held in the portfolios are not as liquid as the larger cap names. Also the active portion held a number of Asian securities in the first quarter that underperformed the Canadian market.

RECENT DEVELOPMENTS

The Fund's Manager has called a special meeting of unitholders for May 15th, at which unitholders will vote on whether to merge this Fund into the Galileo Small Mid Cap Fund.

RECENT DEVELOPMENTS

The Fund has been given exemptive relief from the regulators to invest in the BetaPro family of closed end funds.

RELATED PARTY TRANSACTIONS

Galileo Funds Inc., the Fund's Manager and Trustee, is a wholly owned subsidiary of Galileo Global Equity Advisors Inc., which is the Fund's Portfolio Advisor. Galileo Funds Inc. receives management fees based on the average net assets of the Fund. The management fees are used to pay for sales and commissions, the investment management of the Fund and other general administration. For the period ended December 31, 2008, the total management fees charged by Galileo Funds Inc. to the Fund was \$9,667 (2007 - \$6,412).

The Manager is also the Trustee of the Fund and is responsible for certain aspects of the day-to-day administration. The Fund reimbursed the Manager for certain operating costs incurred in administering the Fund of approximately \$12,668. The Manager absorbed approximately \$76,591 of total expenses. Such absorptions may be terminated at any time without notice.

- (2) Management expense ratio for each class of units is based on the total expenses of the Fund, incurred by or allocated to that class of units for the period shown, expressed as an annualized percentage of the daily average net asset value of that class during the period.
- (3) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a Fund's portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a Fund.
- (4) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.

MANAGEMENT FEES

The Fund pays an annual fee of 1.85% of the net asset value of Class A and 0.85% of the net asset value of Class F plus GST to the Fund Manager in consideration for the provision of management, distribution and Fund advisory services. This management fee is calculated as a percentage of the Fund's net asset value per class and is calculated and credited daily. The Fund is required to pay Goods and Services Tax (GST) on the management fee.

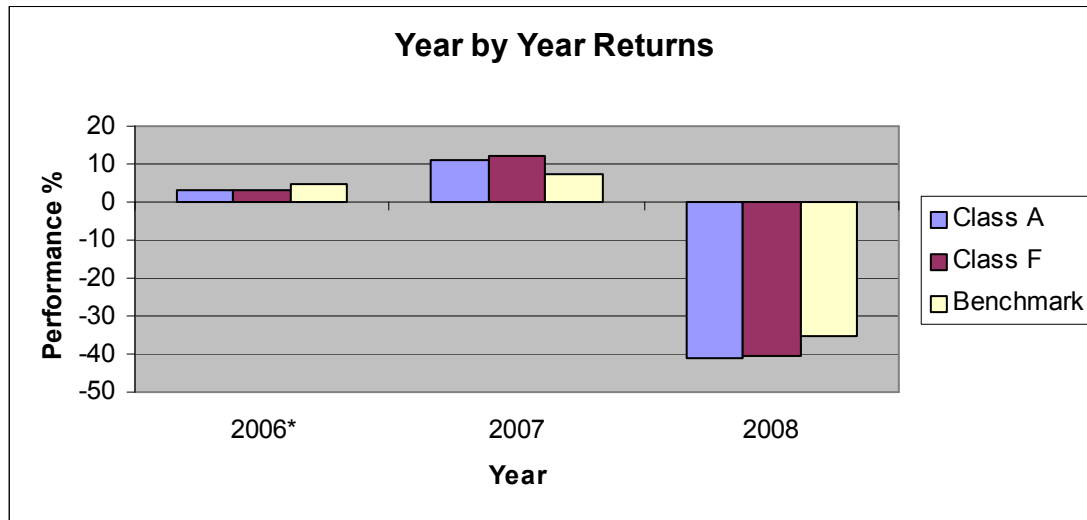
Of the management fees paid by the Fund to the Manager for the Class A units, approximately 53% was used to pay for sales and trailer commissions and 47% was for portfolio management services. Of the management fees paid by the Fund to the Manager for the Class F units, approximately 0% was used to pay for sales and trailer commissions and 100% was for portfolio management services.

PAST PERFORMANCE

The performance information shown below assumes that all distributions made by the Fund in the period shown were reinvested in additional units of the Fund. The performance information does not take into account sales, redemptions, distributions or other optional charges that would have reduced returns or performance. It is important to note that the past performance of the Fund does not tell you how the Fund will perform in the future.
