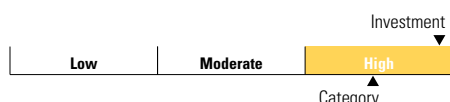

Volatility Analysis

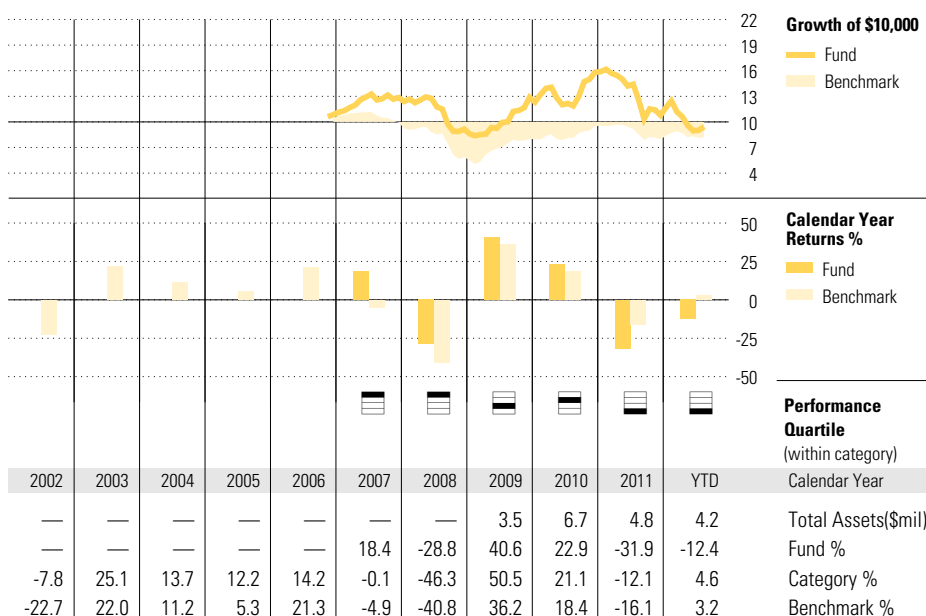

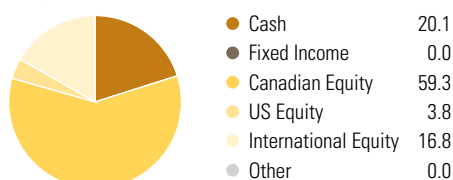

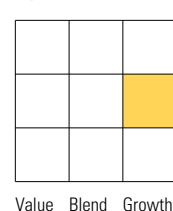
